THIS MONTH'S HIGHLIGHT



Joy Allen PCC backs calls for cut to drink-driving limit

This month, I've called for urgent action to lower the drink-driving limit, endorsing the British Medical Association's proposal to reduce the blood alcohol content (BAC) limit from 0.08% to 0.05%. This change, supported by international evidence, could save over 150 lives annually by reducing road fatalities.

This call for action is underscored by the tragic deaths of 8-month-old Zackary Blades and his aunt Karlene Warner, who were killed when a drunk driver crashed into their vehicle on the A1(M). The offender was found to be driving at 141mph and, when breathalysed, blew 95mg of alcohol per 100ml of breath - the legal limit being 35mg.

In County Durham and Darlington, over 110 people were arrested for drink or drug driving during the Euros, with Durham Constabulary conducting over 800 checks from 14th June to the 14th July. These checks resulted in 114 arrests - 54 for drink driving, 52 for drug driving and 8 for failing to provide samples. Car safety inspections during these stops also revealed defects in several vehicles. My push for a lower BAC limit aims to improve road safety and prevent further tragedies on our roads.

RECENT ACTIVITIES RECAP

Tackling Illegal Vapes, Police Bravery and Support for Prisoners

Collaborative efforts between my
Office, Durham Constabulary and key
partners have led to significant crimefighting successes. A recent operation with
Darlington Borough Council has tackled
illegal vapes. During a day of action, 294
packs of cigarettes, 52 packs of tobacco and
420 illegal vapes were seized. Many vapes
exceeded the legal limit of 600 puffs, with
some containing up to 10,000 puffs.

These illicit products pose serious health risks and fund organised crime, potentially leading to more violent offences and exposing underage children to exploitation. My Office have developed an action plan to tackle this growing concern, to ensure there is no place for illegal vapes or synthetic opioids in our communities.

This month, I had the pleasure of supporting PC Stuart Furlonger at the National Police Bravery Awards in London alongside Chief Constable Rachel Bacon. Whilst responding to a call in September last year, he was rammed by a quad bike and thrown up into the air, breaking his tibia and fibula in his right leg.

The Community Peer Mentor scheme continues to support the most vulnerable individuals, recently expanding into Low Newton prison. Originally started by the late Ron Hogg CBE, the scheme has grown significantly, now including over 300 volunteers with lived experiences. Operated by my office, these mentors aim to inspire confidence in the police and criminal justice system, with a new focus on resettling female prisoners by assisting with housing and employment.

New PCSOs strengthen Neighbourhood Policing

Welcoming 18 PCSOs to Durham
Constabulary, I emphasised my commitment
to a strong local police presence.
Neighbourhood Policing is the public's
top priority and is vital for increasing trust.
PCSOs are valued for their crucial role in
local policing, supporting communities and
deterring offenders.

NEW PROJECTS

Support for Gambling Addictions

I have urged the government to implement a compulsory gambling industry levy without delay to protect addicts. As National Portfolio lead for Addictions and Substance Misuse, I advocate for stronger betting regulations and spearheaded reforms, including Durham Constabulary's Gambling Charter commitment. The government's proposed reforms include a mandatory levy, player protection checks and stake limits.

Expanded naloxone training to 238 individuals across the force and secured funding for drug testing on arrest in County Durham and Darlington

The North East has the highest drug misuse death rate in England and Wales. Since 2019, Durham Constabulary's naloxone-trained officers have saved over 30 lives . PCC Joy Allen has expanded naloxone training and secured funding for drug testing on arrest in County Durham and Darlington. Nationally, nearly 100,000 drug tests have been conducted since March 2022, revealing that 56% of tested suspects were positive

for cocaine, opiates, or both. This testing is vital for reducing re-offending by connecting offenders to treatment services. With current funding ending in March 2025, I am dedicated to securing continued investment.

Early Release Resettlement Support for Prison Leavers

I have raised these concerns with the government to provide better resettlement packages for early-release prisoners to deter reoffending and prevent system failure. Highlighting cases of prisoners released without housing, she stresses the need for practical support to avoid quick returns to prison, exacerbating overcrowding. Allen has raised these concerns with the newly appointed Minister for Justice and Home Secretary and will continue to lobby to prevent re-offending.

PCC'S SPOTLIGHT

As your newly re-elected Police and Crime Commissioner for County Durham and Darlington, I am committed to ensuring that our police force and my office address the priority areas that matter most to the public.
